ADDENDUM I

This Addendum I to Contract SC-28-21 is hereby entered into this the 8 day of June ~~2020~~ 2021 between the **VIRGIN ISLANDS WATER AND POWER AUTHORITY** (herein referred to as the "Authority") and **GLOBAL PROJECT STRATEGY** (herein referred to as the "Consultant"). The Authority and the Contractor shall hereinafter be jointly referred to as "the Parties."

**WHEREAS**, on January 7, 2021, the Parties entered into Contract SC-28-21, where the Consultant agreed to provide professional services to assist the Authority with mediation preparation regarding the default of Petra Systems in the streetlight installation project. A copy of said Contract is attached hereto and made a part hereof as Appendix "A"; and

**WHEREAS**, the Parties jointly agree that due to the voluminous document submission for Consultant's review for the mediation preparation, a six month extension is required, to expire January 7, 2022.


**WHEREAS**, the Parties further agree that due to the extension of the contract, the consideration shall increase in the amount of Seventy Thousand Dollars and 00/100 (\$70,000.00), thereby making the total contract consideration One Hundred Seventy Thousand Dollars and 00/100 (\$170,000.00).

**NOW THEREFORE**, in consideration of the mutual promises and conditions herein, the Parties, intending to be legally bound, agree as follows:

1. That the Preamble to this Addendum I constitute an integral part thereof;
2. That Section 2 of the contract entitled "Consideration" shall be amended to increase the contract consideration in the amount of Seventy Thousand Dollars and 00/100 (\$70,000.00), thereby making the total contract consideration One Hundred Seventy Thousand Dollars and 00/100 (\$170,000.00).

3. That Section 3 of the contract entitled "Term/Progress Reports", is amended to extend the expiration to January 7, 2022.
4. That these provisions do not usurp, nor in any way change any other terms and conditions of the Contract, except as specifically stated herein.
4. That except as expressly amended herein, all other terms and conditions of the Contract remain in full force and effect.
