**LICENSING PARTNER SERVICE AGREEMENT BETWEEN
SOFTWAREONE PUERTO RICO INC. and
VIRGIN ISLANDS WATER AND POWER AUTHORITY**

THIS AGREEMENT is entered into this 4 day of August, 2020, to be effective August 4, 2020 between **SOFTWAREONE PUERTO RICO INC.** ("Software One") located at #48 Carr 165 OFC 310, Guaynabo, PR 00968-8046 and the **VIRGIN ISLANDS WATER AND POWER AUTHORITY** ("VIWAPA"), located at 9720 Estate Thomas, P.O. Box 1450, St. Thomas, USVI 00804. VIWAPA and together with Licensor are referred to collectively as the Parties

WHEREAS, VIWAPA has entered into a Business Service Agreement with Microsoft and SoftwareOne as the Business Affiliate;

WHEREAS, SoftwareOne will manage and service VIWAPA's Microsoft Volume;
and

WHEREAS, Microsoft will invoice SoftwareOne and SoftwareOne will in turn invoice VIWAPA for the Microsoft Volume Licensing.

NOW THEREFORE, the Parties agree that SoftwareOne shall invoice VIWAPA and VIWAPA shall pay to SoftwareOne, pursuant to the Microsoft Volume Licensing - Quote-PR113134 dated April 17, 2020 and identified as Exhibit A, a total amount not to exceed a total of Nine Hundred Ninety Two Thousand Nine Hundred Seven

(\$992,907.00) Dollars) for a 36 month term of the Business Service Agreement for Volume Licensing with Microsoft and SoftwareOne.


The term of this Agreement Term commence on August 4, 2020 and end August 4, 2023.

Payment shall be made as follows based on an annual invoice submitted by SoftwareOne:


