## **ADDENDUM II**

This Addendum II to Contract No. SC-11-20 is entered into on this 30 day of 2020, by and between the VIRGIN ISLANDS WATER AND POWER AUTHORITY (the "Authority") and COMPREHENSIVE SECURITY CONCEPTS, INC. (hereinafter called the "Contractor"). The Authority and the Contractor shall hereinafter be jointly referred to as the "Parties".

WHEREAS, the Parties, on November 27, 2019, entered into Contract No. SC-11-20 (hereinafter the "Contract"), in which the Contractor was to provide and operate armed and unarmed security to the satisfaction of the Authority. A copy of said contract is attached hereto and identified as Appendix "A";

WHEREAS, on June 23, 2020, the Parties entered into Addendum I, which Addendum increased the scope of services under the Contract for Contractor to provide temperature screening at the Authority's facilities. Due to the increase in scope, the Contract consideration increased in the amount of \$76,370.00; thereby, increasing the total Contract consideration to \$1,149,435.00. A copy of said Addendum I is attached hereto and identified as Appendix "B"; and

WHEREAS, the Parties now agree to extend the term of the Contract an additional three (3) months, contract to expire February 28, 2021. Due to the current Contract extension, the Contract consideration shall increase in the amount of \$292,702.50; thereby, increasing the contract consideration to a total of \$1,442,137.50.

WHEREAS, due to the increase of \$292,702.50 in the Contract consideration, an amount equal to Fourteen Thousand Six Hundred Thirty-Five Dollars and 13/100 (\$14,635.13) shall become due and will be withheld for gross receipt taxes.

NOW THEREFORE, in consideration of the mutual covenants herein and the Parties intending to be legally bound hereby, it is agreed as follows:

- That the preamble to this Addendum II constitute an integral part of the Parties' agreement.
- 2. That Clause 2 entitled "Term" shall reflect that the Contract shall be extended an additional three (3) months, to expire February 28, 2021.
- 3. Clause 3, entitled "Consideration" is increased in an amount not to exceed \$292,702.50; thereby, resulting in an increase in the total contract consideration under SC-11-20 in an amount not to exceed \$1,442,137.50.
- 4. That Clause 5, entitled "Gross Receipt Taxes" shall reflect that an additional sum in the amount of Fourteen Thousand Six Hundred Thirty-Five Dollars and 13/100 Cents (\$14,635.13) shall become due and payable for Gross Receipt Taxes.
- 5. That these provisions do not usurp, nor in any way amend the terms and conditions of the Contract, except as specifically stated herein.
